Minutes of the Meeting held on Tuesday 19th January 2010

Present: Cllrs Gannon, Holland, Cole, Moriarty, Leigh-Taylor, Brookes & 3 members of the public.

The Minutes of the Meeting were taken by the Clerk, Mrs Luke.

The Chair, Cllr Gannon welcomed everyone to the meeting and invited members of the public to speak. A local resident requested that he be added to the email circulation list for Minutes and gave his email address to the Clerk.

- 2. Declarations of Interest**

- 3. To approve the Minutes of the Meeting held on 15th December 2009.**

- 4. Matters arising from the Minutes.**
Cllr Holland raised item 9 point 5 and advised the Clerk that a couple of parishioners would like to make contact with this person.
 - a) Cllr Gannon reported that she had received one request for an electronic copy of the survey results.
 - b) It was noted that Devon County Council are still yet to advise on when a Consultation will take place regarding use of horses on the Granite Way.
 - c) The Clerk reported that the Website amendments were taking place and the quoted price was £50.
 - d) The Clerk reported that SWW have confirmed their attendance on 23rd February 2010 at 6.30pm and that she will place a notice on the board. Cllr Gannon advised that she would also mention this in the Parish Magazine.

e) The Parish Lengthsman is due to the Parish on 12th & 13th February 2010. Items to be reported were discussed: to clear leaves at bottom of Hawthorn Park and to clear the drain on the bridge over the Granite Way by Lydford Hotel.

Cllr Holland gave a report on Nicholls Hall in Cllr Boyds absence, including repairs to the front wall and fund raising for Help the Heroes.

The Clerk summarised a newsletter from Devon and Cornwall Police.

The Clerk read out the cheques for signing, these were agreed and the cheques were signed. Cllr Holland requested a grant of £10 be made towards the Vicars retirement lunch and explained that other organisations were also contributing. This was agreed and a cheque signed.
